Project summary

Background: Why did you apply for this project? What were the needs you have addressed?* The project was applied with the aim of solving the issue of increasing the capacity of NGOs with the involvement of educators and increasing the knowledge of these educators to strengthen adult training, which is supported by the "Erasmus" program. Partners as NGO networks (including a total of at least 112 NGOs) needed to expand the circle of educators with this project, because only in rare cases these associated organizations by themselves were able to prepare the applications to the funders. The target group - employees of NGO networks from Latvia, Estonia, Sweden, Italy and Greece, engaged experts and volunteer specialists was interested in social rights and social inclusion, gender equality, innovations in training, access to the digital environment and advocacy, which relates to the areas of activity of these networks in general. All five partners for the last 7-30 years had dedicated their activities to increasing the knowledge and skills of NGO employees and strengthening their networks. The unsatisfactory socio-economic situation of the NGO members in Europe in the last two years encouraged the demand for new knowledge that can be provided by educated workers. The

Objectives: What did you want to achieve by implementing the project?*

The project partners wanted to achieve the following: 1) to strengthen their capacity by providing a network with educators, incl. those with limited opportunities, who have gained access to international non-formal adult education programs; 2) to promote their networks' educators' inclusion in local and international training activities, thus actively strengthening the European dimension. By implementing the project the partners intended to significantly meet the needs of NGOs of their networks for educated staff who are able to provide knowledge and support to NGOs; through trainings the knowledge and skills of NGO educators to increase the awareness in areas where they have insufficient knowledge (social inclusion, etc.); to be able to promote the NGO participation in Erasmus+ programs and the introduction of the European dimension, which will increase the opportunities of NGO networks to promote social security both in their own countries and throughout Europe, as well as provide an opportunity to attract an adequate funding. It was also expected that through mutual cooperation the partners' capacity will be strengthened and will positively affect the achievement of the planned objectives in raising the competencies of NGOs.

Implementation: What activities did you implement in your project?*

During the project, 5 partners implemented a total of 32 activities: 2 management meetings, 25 local workshops and 5 international meetings for educators of disadvantaged groups from NGOs. In the management meetings, project leaders from each NGO network agreed on communication, material preparation and information dissemination measures, on evaluation surveys for each activity, on conducting surveys in connection with innovative courses and collecting the results of these surveys, as well as analyzed the results achieved in the first ten months. In local workshops (5 in each country), training and experience exchange were organized to increase the competence of NGO educators on the topics planned in the project: social inclusion, gender equality, innovative courses for vulnerable groups, awareness of the digital environment and advocacy of the interests of vulnerable groups. In parallel, partners in their countries conducted a survey of local workshop participants on their training needs and topics covered. At the international meetings (1 in each country), the partners presented their experiences to the NGO educators, summarized the results achieved and the proposals received, which related to one of the mentioned topics.

Results: What were the concrete outputs and other results of your project?*

The results: 1) increased quality of NGO networks' work and methods by attracting trained educators, provided by the opportunity to involve 628 participants in training (53% with higher education, 20% with professional education), incl. 69% persons with limited opportunities; 2) developed capacity of the networks' inexperienced NGOs for operating at the international level and in the field related to their objectives, provided by the opportunity for 98 educators to gain experience in international meetings, incl. 69% persons with limited opportunities; 3) increased the knowledge of NGO networks' inexperienced organizations' 628 participants about social inclusion, gender equality, innovations in training, access to the digital environment and advocacy provided by the opportunity to be included in the target group - women 66%, men 44 %, different ages, incl. 30-70 88%, other nationalities 16%, with a lower level of education 27%, with disabilities 10%, immigrants 8% and homeless 1%; 4) promoted changes in the understanding and experience of 726 participants of less experienced organizations of NGO networks (women 66%, men 44%, people with disabilities 9%), aged 18-82, with different levels of education 100%) about Erasmus+ tasks.

What are the concrete outcomes and achievements of your project, and how do they link back to the project objectives? Were all original objectives of the project met? Five partners from Latvia, Estonia, Sweden, Italy and Greece within the project: 1) ensured the involvement of 726 employees from their NGO networks in training, incl. 77% of educators with limited opportunities; 2) the trainings increased the knowledge of the mentioned educators about social inclusion, gender equality, innovations in training, access to the digital environment and advocacy, which were provided by promoting mutual interaction of the participants (women 66%, men 44%, sexual minorities 1%, people with disabilities 9%, aged 18-82, with different nationalities, with different levels of education - 100%, people with low income 60%, immigrants 7% and homeless 1%); 3) developed the capacity of five NGO networks as a whole and the capacity of a significant number of inexperienced NGOs in the networks according to their goals with trained members (staff, experts, volunteer specialists) at the local level (628 participants) and at the international level (98 participants); 4) provided changes to 726 employees, incl. 77% of educators with limited opportunities, awareness and experience of Erasmus+ tasks and the European dimension, linking it to the availability of the digital environment and the preparation of new proposals for the training of vulnerable groups, which was facilitated by the inclusion of these employees in 32 local and 5 international training events and surveys. In this way, the partners achieved both goals that were set: 1) to strengthen their capacity by providing a network with educators, incl. those with limited opportunities, who have gained access to international non-formal adult education programs; 2) to promote their networks' educators' inclusion in local and international training activities, thus actively strengthening the European dimension. Within the implemented project, the initial expectations were exceeded by such achievements as 1) the diversity of the target group attracted by the

partners; 2) the significant total number of NGO employees involved in the training, and 3) the significant number and comprehensiveness of the training participants' proposals related to the training topics offered within the project, as well as innovative training content and methods specifically for the needs of the most vulnerable population groups.

In what way was the project innovative and/or complementary to other projects already carried out? Please describe how the needs of the identified target groups were addressed and what were the benefits of cooperating with transnational partners.*

This project, according to the assessment of the partners, was sufficiently innovative because it paid attention to the educational needs expected by the disadvantaged groups in the five partner countries, and allowed these disadvantaged groups to evaluate themselves and make proposals for improving the content and implementation methods of various educational courses. Strengthening the knowledge of NGO educators regarding social inclusion, gender equality, innovations in training, access to the digital environment and advocacy gave the most effective result with the involvement of educators from the environment of disadvantaged groups themselves (77%), which only NGO networks can provide. With this project, the partners jointly addressed the needs of the identified target groups - NGO educators - by creating training experience exchange programs of appropriate content (with a high-quality agenda at local and international events in Latvia, Estonia, Sweden, Italy and Greece) and ensuring the attraction of qualified specialists in these programs, which prepared the target group for work in NGO networks. This project organically complements several projects of the Erasmus+ programs, within the framework of which partners operate, related to non-formal education of adults. For example, partners from Latvia, Estonia, Sweden, Italy and Greece increased the knowledge of NGO employees to work with less protected groups in the Latvian partner's project "Building a Network to Boost Social Secure Europe" 2020-2023. year. Latvian and Italian partners increase the knowledge of their network employees about solving homelessness problems in the Belgian partner's project "Person First: Services and Rehabilitation supports promoting accessibility - improving e-quality - reinforcing net-working" 2022-2024. year. Partners from Latvia, Sweden, Italy and Greece regularly improve the knowledge of their employees in the Latvian accredited consortium project 2022-2027. year. Considering the similar objectives and nature of the NGO networks coordinated by the project partners strengthened the expansion of the knowledge and experience of the relevant educators at the European level. Project partners who had previous experience in Erasmus+ partnerships, played an important role in the cooperation process in order to transfer their experience to the less experienced partners. These are also the biggest benefits of cooperation between international partners.

How was the progress, quality and achievement of the project activities monitored and by whom?* In order to monitor the course of project activities over 18 months, quality and achievements, the partners ensured administrative and evaluation process by strengthening mutual cooperation, leadership and maintaining regular communication, incl. remotely. All partners have access to modern technologies and an Internet connection. Within the project, two activities were implemented under the leadership of the Latvian partner webinars on communication, material preparation and information dissemination measures, on evaluation surveys for each activity, on conducting surveys in connection with innovative courses and collecting the results of these surveys, as well as analyzed the results achieved in the first ten months. Managers of all five partners participated in the webinars, who were authorized to represent their networks and under whose leadership the process of evaluating the activities - local workshops and international meetings - from both a substantive and administrative point of view, and collecting participants' proposals for innovative training courses for disadvantaged population groups took place. The administrative staff of the project (1-2 in each partner organization) in Latvia, Estonia, Sweden, Italy and Greece monitored the process of involvement of the relevant target group, the preparation of relevant training agendas, the attraction of qualified specialists and the participation of stakeholders in the training process, as well as the issuing of relevant evaluation questionnaires and proposals preparation of questionnaires. The partners monitored the achievements of the project, facilitating the preparation of reports on the progress and results of the activities in the partner countries and providing

summaries of the participants' proposals. The discussion and gathering of experiences of NGO educators in seminars in Latvia, Estonia, Sweden and Greece on the results of the local workshops held in the partner countries and at the conference in Italy on the results of the project as a whole was of significant importance in the monitoring of achievements. As part of partner monitoring measures, financial control was also carried out, so that appropriate investments were made in the organization of both local workshops and international meetings. This applied both to ensuring the well-being of the target group, to foreign trips, and to the preparation of the informational base. The main control over the execution of the partnership agreements, compliance with the schedule of project activities and progress, their quality and achievements, as well as control over the use of funds was carried out by the leading partner from Latvia.

How did you evaluate the extent to which the project reached its objectives and planned results? Which activities did you carry out to assess the overall success of your project?*

In order to assess the extent to which the project achieved the set goals and planned results (see section 1), the partners used several methods, the main of which was surveys of the target group of activities - NGO educators - to ensure their satisfaction; surveys were conducted with a special questionnaire, giving the opportunity to evaluate both the administrative management and the achieved results in terms of benefits and cooperation with other partners and stakeholders on a scale from 1 to 10. Overall, the average score from the point of view of the target group was 9.5 points. The evaluation of the set goals was also evidenced by the involvement of activity participants in expressing proposals, which were made in the aforementioned questionnaires regarding the specific topic of the workshop or international meeting: social inclusion, gender equality, innovations in training, access to the digital environment and advocacy. At the end of the project, these proposals are summarized in a single report. The achievement of the project's goals was also evidenced by the active involvement of NGO network employees (628) in expressing proposals intended for the involvement and training of less protected population groups. At the end of the project, these proposals are also summarized in a single report. An assessment of the project's overall activities was also provided by the statistical indicators of the number of implemented activities (32), the number of participating participants (726), the number and types of specialists and stakeholders involved (32 agenda descriptions), as well as the amount of presentations and handouts at the events. At the end of the project, two reports were prepared with statistical information on the capacity of educators of the NGO networks involved in the project. The leading partner from Latvia regularly followed the schedule of the implementation of activities and gave its evaluation of the results in the corresponding section of the EC portal on a scale from 1 to 10. Summarizing these evaluations, it can be seen that the implementation of the project corresponds to an average of 9.5 points. The evaluations were reduced solely for the deficiencies in the administrative work of the partners; moreover, during the implementation process, these shortcomings were mostly eliminated. No inconsistencies were found in the content of the activities implemented by the partners, ensuring the planned results. Information about the overall success of the project was also provided by the amount of publicity measures, such as information and photos on the website of the Latvian partner http://www.eapn.lv/erasmus plus small/, on the websites of Estonian, Swedish and Italian partners, on social networks (Facebook, etc.) created by Latvian, Estonian, Swedish and Greek partners, also in the Latvian partner's monthly newsletter "News"; the significant number of events in general ensured accessibility for public evaluation.

If relevant, please describe any difficulties you have encountered in managing the implementation of the project and how you and your partners handled them. How did you handle project risks (e.g. conflict resolution processes, unforeseen events, etc.)?

During the implementation of the project, the leading partner of Latvia, together with other partners, had to solve several issues of an administrative nature, which were related to maintaining the schedule of activities or involving the appropriate target group. For example, due to serious family circumstances and illness of employees, it was necessary to change the time of the international meeting in Sweden (from November 2022 to April 2023) and to cancel the participation of the Swedish people in the meeting in Greece (July 2023). Also, changes in the schedule were necessary when organizing the workshops in Greece (moved from February to



November 2022), which was related to the reorganization and change of employees within the partner organization. But due to vacations and climatic conditions, the conference in Italy had to be moved earlier (from August to June 2023) than planned in order to fit into the project implementation period. As for the target group - NGO educators - the project partners did not always correctly assess their status and role for work in the NGO network and society as a whole. Therefore, the lead partner repeatedly had to clarify the information about the target group in the local workshop; together with Swedish, Italian and Greek partners this problem was solved. During the implementation of the project, problems were eliminated, as the partners managed to mutually coordinate the participation of the relevant target group and the schedule of activities, as well as ensure the receipt of informative materials in full, as all five project partners participated equally in decision-making (both in administrative webinars and during meetings abroad, both in special online meetings and e-mail correspondence). The opportunity given by the Erasmus+ program to involve asylum seekers from Ukraine in the project activities, promoting their inclusion in educational programs, can be considered an unexpected event. It was successfully solved by project partners from Sweden and Estonia. Partners in the project maintained friendly relations, without any conflicts in the process of overcoming difficulties.

What were the strengths that each partner brought to the project? Please describe how the tasks and responsibilities were distributed among the partner organisations.*

Five partner organizations were involved in the project - from Latvia, Estonia, Sweden, Italy and Greece. The role of the leading partner was assumed by the Latvian partner, whose responsibility was wider than that of the other partners, specifically: 1) general management and supervision of project implementation, incl. publicity

monitoring; 2) financial control and supervision of financial utilization; 3) coordination of cooperation between partners; 4) organization of evaluation events and preparation of reports. In addition, the duties of the Latvian partner also included the organization of 2 administrative webinars for partner managers, 5 local workshops and one international seminar in Latvia for NGO educators, incl. for employees from less protected groups (NGO network administrators, experts and volunteer specialists). The organizing process included the involvement of the relevant target group, attracting lecturers, experts, consultants and moderators, preparation of agendas, preparation of publicity and informational materials, material and technical provision, incl. computer technology, communications and stationery, space rental, transport, catering, hotel and flight provision. In order to implement the mentioned measures, the Latvian partner creates the opportunity to attract employees (project coordinator and administrator), as well as NGO educators, based on the human resources of its network. The strength of the Latvian partner was previous experience (at least 8 years) in adult education programs, especially in working with less protected groups. The responsibilities of the partners from Estonia, Sweden, Italy and Greece included the organization of 5 local workshops and one international seminar for NGO educators in each country, incl. involving employees from disadvantaged groups. In order to carry out the mentioned measures, the Estonian and Swedish partners create the opportunity to attract two employees each (a project manager and an administrator), the Greek partner attracted a project manager, an administrator and a PR manager, and the Italian partner - a project manager and three administrators, as well as experts and volunteer specialists, drawing on the human resources of their networks. Similar to the Latvian partner, the Estonian, Swedish, Italian and Greek partners also ensured the involvement of the appropriate target group, attracting lecturers, experts, consultants and moderators to workshops, seminars and conference, preparation of agendas, preparation of publicity and informative materials, the material basis, etc. The strength of the Estonian partner was many years of previous experience in Erasmus+ adult education programs. The strength of the Swedish partner was previous experience in other adult education programs and working with female audiences. The strength of the Italian and Greek partners was the long-term work in strengthening the education and social inclusion of the less protected groups.

How did you ensure sound management of the project and good cooperation and communication between partners during project implementation?*

The project partner from Latvia ensured proper project management by inviting partners from Estonia, Sweden, Italy and Greece to familiarize themselves with the management of the Erasmus+ program, observing the agreements concluded with the partners, providing the partners with a full description of the project and additionally providing detailed information about the project's goals and activity plan, by issuing recommendations on publicity measures and use of logos, as well as ensuring accessibility to the project's main website http://www.eapn.lv/erasmus_plus_small/ and Facebook page https://www.facebook.com/laila.balga/, as well as inviting partners to mutually exchange publicity information. In addition, the Latvian partner regularly promoted the maintenance of the schedule of events and the coordination of changes between all partners throughout the project implementation, provided partners with recommendations on the conduct of events in accordance with the project content, work agenda and samples of evaluation questionnaires, provided survey summaries, as well as reports on the investment of Erasmus+ funding. During the implementation of the project, it was possible to ensure good communication between partners because all partners were sufficiently motivated to implement the Erasmus+ project, to achieve the results set in the project - strengthening the capacity of the NGO network with educated employees, increasing the knowledge of NGO educators and preparing proposals for the creation of innovative training courses in the interests of less protected groups. Also, the partners were united by the goal of involving people from less protected groups in the environment of NGO educators, who are mostly members of NGO networks of partner countries and are better acquainted with the needs of such a group. An important role in strengthening communication was played by the international meetings, where the leading educators of the partners discussed and where the leading partner could thank other partners for the work done. It must be recognized that an important role in strengthening cooperation was played by the partners' interest in attracting funding from the Erasmus+ program, which could facilitate the development of new cooperation at the European level, so that it would be possible to implement the goals of the partner



organizations. Successful cooperation within the framework of this project was also facilitated by the previous common experience of Latvian, Estonian, Swedish, Italian and Greek partners in several other Erasmus+ program projects from 2020 to 2023 (e.g. Strategic Partnership). By exchanging experience within the framework of the Small-scale project, thus taking over the experience of a more knowledgeable partner (for example, Estonia), the capacity of less experienced partners (for example, Italy) was increased. This provided the basis for the continuation of the partnership within the Erasmus+ programs.



Local workshop of NGO educators on competencies for advocacy of vulnerable people in Latvia

Describe the content of the proposed activity.

The content of this local workshop is aimed at increasing knowledge and skills to promote the advocacy for the interests of vulnerable groups, to which the NGOs contribute in accordance with their objectives. The legal and operational nature of the partner (the NGO network) makes it necessary to discuss during this workshop the capacity of network organizations for advocacy in state and local government decision-making institutions. This workshop will address issues related to the knowledge and practical experience of NGO staff to establish communication with officials, prepare relevant documents, participate in discussions in working groups and conferences and follow up on the enforcement of decisions related to meeting the needs of vulnerable groups and other social inclusion issues. Through the analysis of the results of the survey of vulnerable groups, which was carried out during the previous workshop, materials and discussions, partner's educators will share their experiences of the situation in the field of advocacy within their network and will compile proposals that will contribute to strengthening advocacy. This workshop will also provide an opportunity to involve in the discussion participants from vulnerable groups (from different network organizations) and who have never been involved in the Erasmus+ projects. The knowledge of NGO educators will be improved by discussing and planning the objectives and content of the training courses, as well as by getting acquainted with the relevant laws, regulatory enactments and other information materials, incl. in the context of the European dimension. At the end of this workshop, it is planned to evaluate the achieved results, as well as to ensure their publicity, following the Erasmus+ guidelines. The activities will take place in a local language, the local partner will prepare the agenda of this workshop and will attract participants in due time. The partner will compile information to the conference in Italy.

Describe the target group for this activity. Who is going to take part and who is going to benefit from the results

The target group of this activity are NGO educators from the partner organization's network - staff, experts (employees with long-term and comprehensive experience in the non-governmental sector) and volunteer specialists, a total of at least 20 participants. This target group is interested in advocacy issues for the interests of vulnerable NGO members to be addressed in co-operation with parliamentary, public administration and local government institutions, related to the scope of their organization and of the network as a whole. The composition of this target group is close to the composition of potential participants, whose interests need to be defended, which gives an advantage in planning the relevant communication, as well as information and training content – these are people of different ages, nationalities, both sexes, including people with disabilities and low-income workers. However, every target group member's level of education and previous experience in promoting non-formal adult education are key determinants for them to participate and expand their knowledge in this Erasmus+ training program, then pass on their knowledge to the most vulnerable members of their network organizations. Attracting educated professionals to the NGO network will be an important tool for the implementation of non-formal training courses, which will strengthen the NGO advocacy in the partner country.

Explain how is this activity going to help to reach the project objectives.

This activity planned in the form of a workshop will increase the competence of at least 20 NGO educators in connection with the research on the needs of disadvantaged groups of population, advocacy methods and nonformal trainings to enable these groups to integrate equally into the socio-economic environment. This activity intends to achieve the goals aimed at the ability to work at the international level, the availability of the projects supported by the Erasmus+ program (by providing training and exchange of experience for the staff of the partner organization's network), to support the inclusion of NGO staff who have limited opportunities themselves in training activities related to the advocacy for vulnerable groups of population, to promote the development of



the European dimension at the local level in this partner country, as well as to build the capacity of the NGO network for defending the interests (advocacy) of the participants.

The local workshop was implemented in 2 August 2023 in Salacgriva county, Latvia, by partner EAPN-Latvia in cooperation with NGO "Aicinajums Tev", led by Marite Rozentale, Chairperson of the Board. The activity increased the competence of 23 NGO educators in the field of social inclusion. The target group of this activity was NGO educators - staff, experts and volunteer specialists with various ages (35-79), Latvian nationality (23), both sexes (17 women, 6 men), pensioners (6), persons with disabilities (14), persons with different educational level (higher - 5, professional - 11, secondary school - 6, elementary school - 1). However, every target group member's level of education and previous experience in promoting non-formal adult education are key determinants for them to participate and expand their knowledge in this activity, then pass on their knowledge to the members of their organization, especially to the most vulnerable people. This workshop also provided an opportunity to involve in the discussion the participants with less experience in the programs offered by Erasmus+ and in the context of the European dimension. Attracting educated professionals to the NGO network will be an important tool for increasing people's well-being in Latvia. At the end of this workshop, the results achieved were evaluated and no less than 7 proposals were summarized.

presentations, informative materials and discussions, NGO educators from Latvia, Estonia, Italy and Greece -Ineta Stadgale, Eduards Soskovs, Ruta Pels, Leonid Smulskiy, Jacopo Lascialfari, Lucia Scarlato, Spyridon Psychas, Mado Baboula, Maria Tzanetaki, Asimina Lixourgioti, Alex Nassos - shared their experiences and put together proposals that will contribute to creating innovative courses for disadvantaged groups in the partner countries and across Europe. The seminar started with a welcome speech by the Mariannella Kloka, HAN President. The project partner HAN introduced three presentations to the participants and provided an opportunity to share practical experiences related to successful social inclusion in the partner organizations/institutions of Latvia, Estonia and Italy. All information about the course of the seminar and the achieved results was sent to the project partner from Sweden. From the activity results, NGO educators from partner organizations' networks were going to benefit: they are staff members, experts and volunteer specialists, a total of 11 participants. The target group members are people of different ages (27-65) and nationalities (5), both sexes (6 women, 5 men), students (3), low-income workers (2), with large family (1), pensioners (2). However, each target group member's level of education (11 - higher education) and previous experience in promoting non-formal adult education are key determinants for them to participate and expand their knowledge in this activity. At the end of this seminar the achieved results were evaluated and no less then 4 proposals of the participants were summarized.

The project partners introduced 7 presentations to the participants and provided an opportunity to share practical experiences related to successful social inclusion in the nine Latvian organizations/institutions which was provided by EAPN-Latvia. From the activity results, NGO educators from partner organizations' networks were going to benefit: they are staff members, experts and volunteer specialists, a total of 28 participants. Local workshop of NGO educators on competencies for advocacy of vulnerable people in Sweden

Describe the content of the proposed activity.

The content of this local workshop is aimed at increasing knowledge and skills to promote the advocacy for the interests of vulnerable groups, to which the NGOs contribute in accordance with their objectives. The legal and operational nature of the partner (the NGO network) makes it necessary to discuss during this workshop the capacity of network organizations for advocacy in state and local government decision-making institutions. This workshop will address issues related to the knowledge and practical experience of NGO staff to establish communication with officials, prepare relevant documents, participate in discussions in working groups and conferences and follow up on the enforcement of decisions related to meeting the needs of vulnerable groups and other social inclusion issues. Through the analysis of the results of the survey of vulnerable groups, which was carried out during the previous workshop, materials and discussions, partner's educators will share their experiences of the situation in the field of advocacy within their network and will compile proposals that will contribute to strengthening advocacy. This workshop will also provide an opportunity to involve in the discussion participants from vulnerable groups (from different network organizations) and who have never been involved in the Erasmus+ projects. The knowledge of NGO educators will be improved by discussing and planning the objectives and content of the training courses, as well as by getting acquainted with the relevant laws, regulatory enactments and other information materials, incl. in the context of the European dimension. At the end of this workshop, it is planned to evaluate the achieved results, as well as to ensure their publicity, following the Erasmus+ guidelines. Attracting educated professionals to the NGO network will be an important tool for the implementation of non-formal training courses, which will strengthen the NGO advocacy in the partner country.

Through informative materials and discussions, NGO educators from Latvia, Estonia, Sweden, Italy and Greece - Lucia Scarlato, Giulia Morigoni, Giorgio Gabriele, Jacopo Lascialfari, Ingmarie Rohdin, Asa Hedlin Olsson, Inga-Lill Rohdin, Ruta Pels, Leonid Smulskiy, Pavel Smulski, Spyros Psychas, Kitija Bite and Olga Karklina, as well as 20 stakeholders from Italy - shared their experiences and put together proposals that will contribute to the improvement of the socially inclusive environment and the inclusion process - both in the partner countries and across Europe. This activity intends to achieve the goals aimed at the ability to work at the international level, the availability of the projects supported by the Erasmus+ program (by providing training and exchange of experience for the staff of the partner organization's network), to support the inclusion of NGO staff with disabilities in training events in this field, to promote the development of the European dimension at the local level in the partner country, as well as to build the capacity of the NGO network.

Describe the expected results of the activity.

With this activity we intend to achieve the following results: 1) to organize one local workshop; 2) to increase the knowledge and practical experience of at least 20 NGO educators; 3) to prepare and distribute a significant



amount of informative materials and handouts on the topic of this workshop.

Please explain how did you determine the grant amount allocated to this activity? We plan to spend the grant amount of 600 euros as follows: 1) local transport - 100 euros, 2) coffee and snacks for 20 workshop participants - 140 euros, 3) the preparation of informative materials and handouts - 320 euros, 4) stationery and office supplies - 40 euros.

Was the grant amount allocated to this activity sufficient? Yes

Please describe the content of implemented activity if activity deviated from the content of the proposed activity

The local workshop took place on July 12, 2022, in Florence, Italy, it was organized by Coordinamento Toscano Marginalita and led by Jacopo Lascialfari, Director, Project Manager. The activity increased the competence of 21 NGO educators in the field of social inclusion. The target group of this activity was NGO educators - staff, experts and volunteer specialists with various ages (30-80), various nationalities (17 Italians, 2 Moroccans, 1 Kosovar, 1 Albanian), both sexes (11 women, 10 men), immigrants (2), persons with low-income (12), seniors with low-income (2), unemployed person (5), persons with different educational level (higher - 10, professional -7, basic - 3). However, every target group member's level of education and previous experience in promoting non-formal adult education are key determinants for them to participate and expand their knowledge in this activity, then pass on their knowledge to the members of their organisation, especially to the most vulnerable people. The legal and operational nature of CTM made it necessary to discuss during this workshop the capacity of the network to pursue its goals for social inclusion. Through informative materials and discussions, CTM educators Jacopo Lascialfari, Paola Baldinotti, Giorgio Gabriele and Enrico Palmerini shared their experiences of the situation within the network and put together proposals that will contribute to the improvement of the socially inclusive environment and the inclusion process. This workshop also provided an opportunity to involve in the discussion the participants with less experience in the programs offered by Erasmus+ and in the context of the European dimension. Attracting educated professionals to the NGO network will be an important tool for increasing people's well-being in Italy. At the end of this workshop, the results achieved were evaluated and no less than three proposals of the participants were summarized.

The rating was reduced for the following reason: the activity was not provided with CTM presentations and photos. CTM provided the project with informative materials of the local workshop progress and results. Information about the local workshop in Italy was distributed on the central website http://www.eapn.lv/erasmus_plus_small/ and on the websites of partners and stakeholders. The activity was moved from June to July 2022 at the request of CTM, in coordination with other partners, to ensure the simultaneous participation of relevant target groups and specialists.

Impact and Follow-up

How did the participation in this project contribute to the development of the involved organisations? What was the project's impact on the participants, target groups and other relevant stakeholders?*

Participation in this project contributed to the development of partner organizations - NGO networks - in Latvia,



Estonia, Sweden, Italy and Greece with sufficient effectiveness. First of all, with Erasmus+ co-financing used in training and exchange of experience, the basic tasks of the partners were implemented in five areas: social inclusion, gender equality, innovations in training, access to the digital environment and advocacy, as human resources were created for the continuation of adult education programs. In addition, a significant contribution was made to the further strengthening of the mentioned areas with the preparation of two proposal packages and statistical data, the information of which can be used as a basis for planning new projects in these partner organizations. An important factor in the development of organizations is the development of international cooperation and the strengthening of the European dimension in their activities, which is promoted by Erasmus+ programs. For all project partners, it is related to the strengthening of social security. Such an opportunity is provided by the educated staff of NGO networks of partner countries, incl. a significant number from the most vulnerable population groups. Such an advantage is given only to organizations working in the nongovernmental sector. Therefore, the Small-scale project has influenced both the target groups - a significant number of NGO employees, experts and volunteer specialists as educators, as well as the stakeholders of these networks, as similar policy makers, the interests of contributing to the increase of the capacity of NGO networks and increasing the knowledge of other participants. The above was concluded from surveys of the project's target group (summaries of 30 questionnaires) and the involvement of a wide range of stakeholders in the implementation of project activities at both the local and international level (content of 30 agendas). The project brought some effectiveness to the partner organizations through its dissemination through publicity events. Both information about the operation of the NGO networks themselves, and about the results regarding the significant number of trained educators, and about the needs of people from less protected groups are updated to the public on websites, social networks, circulars, media, etc. promotes the development of five NGO networks. It should be emphasized here that the Erasmus+ project gave a large number (726) and very different NGO workers (statistics) the opportunity to become public educators because they are together with other people in the non-governmental sector, understand the needs of problematic groups in society and are able to talk with these groups. It is possible that the project partners, despite the very strong competition, will be able to develop their activities in the above-mentioned areas within the framework of new programs co-financed by the European Commission.

How did you make the results of your project known within your partnership, in your local communities and in the wider public? Who were the main target groups and what channels did you use to share your results with them?*

The project partners regularly disseminated the results of this project: on the achievement of project objectives in the field of social security, on the results of project activities and the participants involved in them. Basically, local communities and wider society in partner countries and at the European level could receive information through websites (the central one is the Latvian page http://www.eapn.lv/erasmus_plus_small/, partner pages: Estonian http://www.ptpest.ee/1082231.html, Swedish https://b-creative.link/ project, Italian https://www.coordinamentotoscanomarginalita.it/european-projects/), via Facebook (Latvian page https://www.facebook.com/laila.balga/, Estonian page https://www.facebook.com/BCreativeAssociation, Greek pages

Latvian and Swedish partners were also registered and posted information on the EPALE portal. The dissemination of results on specific topics - social inclusion, gender equality, innovations in training, access to the digital environment and advocacy - also took place through the informative materials (the agendas of the seminars and workshops, presentations, informative and handouts, evaluation materials etc.) distributed during meetings and workshops. The most comprehensive information on the results was provided to the members of NGO networks in the partner countries, also staff, experts and volunteer specialists involved in this project. Information about the

project partner was provided by stakeholders and local municipalities, partly also by state institutions of the relevant sector, for example, in Latvia, the Welfare Department of the Riga City Council and the Social Inclusion Policy Coordination Committee of the Ministry of Welfare. Information was distributed both by e-mail, online and during personal meetings. During the meetings, the partners and their representatives have the opportunity to present the goals and results of the Small-scale project to European-level stakeholders, such as the European Anti-Poverty Network - EAPN (with 40 NGOs), FEATSA, SMES-Europa, etc., whose members are Latvian, Italian and Greek organizations.

What was the impact of the project at the local, regional, European and/or international levels? Do you have plans to continue using the results of the project or continue to implement some of the activities after the project's end?*

The impact of the Small-scale project implemented by partners from Latvia, Estonia, Sweden, Italy and Greece was varied at different levels. For example, it had an influential role at the local level in all partner countries, because the NGO network was more recognizable at this level, it gave the opportunity to involve local specialists both from their own network and stakeholders. A greater response to participate in local workshops came from local NGO employees, incl. from the less protected groups who continue to operate in their territory even after the training. On the other hand, the impact of the project at the regional level was more visible in Latvia, Italy and Greece, where NGO networks cooperated more widely with stakeholders, and NGO employees from different territories and less protected groups could participate in local workshops. In this way, these partners can spread their information more widely after the project and offer the knowledge of NGO workers trained in the Erasmus+ program. At the European or wider international level, the impact of the project was more manifested in the form of information transfer, when all partners, working in other (both led by the Latvian partner and in cooperation with organizations from other countries) Erasmus+ co-financed projects or operating in international organizations (e.g. EAPN-Europe, etc.), create an opportunity to share experience on Small-scale project implementation and results. In this way, the partners explained the necessity of training NGO educators and promoted the formation of new partnerships in Europe and other foreign countries in the areas of strengthening social security. It must be recognized that the Small-scale project broadened the view of the Latvian, Estonian, Swedish, Italian and Greek partners on the needs of the less protected population for educators, incl. with a view of the European dimension, and increased experience in the implementation of Erasmus+ programs both in their countries and internationally. Taking into account the results of the project such as statistical indicators of the target group, a package of proposals for solving social inclusion, gender equality, innovations in training, access to the digital environment and advocacy issues and a package of proposals for preparing innovative educational programs for the needs of disadvantaged groups, the partners proved their interest and the need to continue developing educational projects.

The partners of this project recognize the necessity of small-scale type projects and the form of its financing. The technical side of the application is also satisfactory. However, it must be recognized that the volume of this type of project tenders and available total funding for partner countries is too small, so good projects are not supported, which has a very negative effect on non-governmental organizations, which do not have sufficient opportunities to apply for large projects. A clearer form of reports on the EC portal is desirable, as it is not clear what kind of answers and to what extent should be provided in the report on activities; the questions asked do not correspond to the requested answers; the regular use of the budget is not transparent. If the number of activities is greater, it is technically difficult to navigate the portal to find the required activity. The partners failed to develop a high-quality practice for the first time as part of the Small-scale competition, due to the lack of experience in determining the composition of the target group - educators and their attraction, as well as in determining the capacity of this target group. The Latvian partner had set too complicated requirements for other partners in this matter. When preparing the final report, it was not clear how to account for the actual size of the target group. However, it is important to emphasize that all partners gained new experience in order to pay more attention to the preparation of NGO educators.
